What is this product?

Type

This product is a sub-fund of an open-ended umbrella fund authorised by the CBI pursuant to the UCITS Regulations (as amended).

Term

This investment has no maturity date. The Company has the right to terminate the product in a limited number of circumstances, as set out in the Prospectus. The PRIIP Manufacturer, Waystone Management Company (IE) Limited, is not entitled to terminate the product unilaterally.

Objectives

The Fund seeks to achieve long-term capital growth by investing mainly in shares of publicly listed companies (equities) and other types of investments that are referenced to such equities (known generally as equity-linked securities). The Fund seeks to identify companies with a sustainable competitive advantage, a superior business model and a high-quality management team at attractive prices that do not fully reflect their long-term growth potential. The Fund is actively managed and run on an entirely discretionary basis. The Fund is not managed in reference to any benchmark. The geographical focus for investments is companies

of different sizes which are located worldwide. In general, the Fund will invest no more than 35% in a single country other than the US, no more than 30% in emerging markets and no more than 25% in a particular industry. On a limited basis the Fund may invest indirectly in such equities using financial instruments commonly referred to as derivatives. The Fund may also invest indirectly in such equities through the use of other funds and investment techniques may be used to protect the value of the Fund. Investors can sell their shares in the Fund on each business day in Dublin and on each day the New York Stock Exchange is open by submitting an application to the Fund's administrator before 3 p.m. (Irish time).

The depositary for this product is J.P. Morgan SE (Depositary).

Distributions are intended to be made out of income and on an annual basis.

Intended Retail Investor

A typical investor in the Fund is an institutional or professional investor, being a corporate, pension fund, insurance company, public sector body such as a governmental, supranational agency or local authority, bank, other investment firm or any other intermediary. This may also include high net worth individuals and private wealth management advisers and firms.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes that you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Performance Scenarios

The figures shown include all the costs of the product itself, and includes the costs of your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product and a suitable benchmark over the last 10 years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

The unfavourable scenario occurred for an investment in the benchmark between August 2021 and December 2023.

The moderate scenario occurred for an investment in the benchmark between October 2014 and October 2019.

The favourable scenario occurred for an investment in the benchmark between February 2016 and February 2021.

What happens if Waystone Management Company (IE) Limited is unable to pay out?

The Management Company of the Fund has no obligation to pay out since the Fund design does not contemplate any such payment being made. You are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depository. Should the Fund default, the depository would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year, you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
